### Minutes of Meeting:

1. Mr. Principal/Member Secretary shared his greetings to all the members of the Governing Council [GC].
2. To cater the need of Human Resources across all the Programmes, the HR department of SVCE have recruited faculty members and staff. The same is presented to GC and member approved the same (Refer Annexure-III).
3. The Member Secretary communicated to GC members that all salary arrears are credited to all the employees post pandemic.
4. Based on statistics of previous five-year admission, the following recommendation are submitted before the GC for AY 2022-23
  - a. Reduction in intake of Electronics and Communication Engineering Programme from 120 to 90. Members recommended to retain as 120 for subsequent academic year.
  - b. Reduction in intake of Civil Engineering Programme from 60 to 30. Approved by the members of GC.
  - c. Closure of Mechanical Engineering Programme. Increase in intake of Computer Science and Engineering with specialization in Artificial Intelligence from 60 to 120. Members informed to check the eligibility for an increase in the intake of new programmes.
  - d. Starting new Programme in Computer Science and Engineering with specialization in Cyber Security, IOT and Blockchain Technology.
  - e. Starting a new Programme in Computer Science and Engineering with specialization in Data Science.
5. The GC member Dr. Vijila Kennedy has shared her opinion to have strong industry connect for the new programme that is proposed to be started from AY 2022-23. Professor Dr. Venkatshiva Reddy shared the details of experts available in Cyber Security domain and suggested to conduct Value Added Programme as content beyond syllabus.
6. The GC member Dr. Jayashankar Variyar said that in all the new courses we need to nurture the student to build their career rather contented with initial jobs. He also said that we need to promote more entrepreneurs during their course of study. He also suggested to imbibe multi-disciplinary domain abilities among all students as a process of implementing National Education Policy NEP-2020.
7. All the members cautioned on closure of Mechanical Programme and suggested starting multidisciplinary Programmes like Robotics and Automation, Cyber Physical Systems to utilize the infrastructure established for the core Programmes. Instead of closure they recommended reducing the intake to 30 from 60.
8. Post discussion the members approved all the recommendations proposed by the member secretary for change in Programmes.
9. Member Secretary has informed that we are in the process of submitting the application for subsequent NBA accreditation for Computer Science and Engineering Programme and Electronics and Communication Engineering Programme. All the members approved the process.
10. The management have proposed that they extend the benefits to all employees by introducing group insurance across our group of institutions. All the members have approved and appreciated the initiative.
11. Member Secretary have said to meet the current industry requirements the soft skill and quantitative aptitude training will be integrated in the regular timetable. The training will be started from third semester onwards.
12. The Management has initiated renovation to the girls' and boys' hostel to accommodate more residential candidates. The GC members have approved and appreciated the initiative.

13. The GC members have suggested training all the faculty members in multidisciplinary domain and shall be provided the opportunity to handle courses in different domains. They also suggested motivating the faculty members and staff to participate in the Atal Faculty development programme, SWAYAM and NPTEL courses.
