Prabhakar Reddy, Principal & Dr. Shivashankar, Professor & HOD (E&CE), SVCE, Bangalore which expression shall mean and include its successors in office and assigns.

LIVEWIRE, The party of the first part shall provide:

- Training on skill development tools opted by the students.
- · Course completion certificate and material will be provided.
- · Will assist in software Installation.
- · Qualified trainees for the conduct of the course.
- · Periodical assessment of the progress of students for their further improvements.

The College, The party of the second part shall provide:

Time Schedule:
